- By joining the affiliate scheme with Hatch Programme Limited you are agreeing that you have read and understand the terms and conditions of this agreement and that you agree to be legally responsible for each and every term and condition.

1. Overview

This Agreement contains the complete terms and conditions that apply to you becoming an affiliate in the Hatch Programme Limited scheme.

The purpose of this Agreement is to allow you to earn a commission by recommending our programmes onto your clients/patients/students.

Please note that throughout this Agreement, "we," "us," and "our" will mean Hatch Programme Limited, and "you," "your," and "yours" will mean the affiliate.

This Agreement will begin upon our acceptance of your Affiliate application, and will continue unless terminated hereunder.

2. Joining our Affiliate Programme

To begin the enrolment process, you will email us at info@hatchoutofyourshell.com with the following information:

- Full Name
- Address
- Email address
- Business Name
- Practice/school details
- Bank Payment details-IBAN /SWIFT Number for commission payments(please see below for full details of payments)

We may reject your application at our sole discretion.

3. Logging into the Portal

Once we have this information we will register you as a member of our Affiliate Program and you will receive an **Express sign-in link** to take you to the Hatch online learning portal.

As an affiliate user, you get your own menu to view general information, links, and referral codes, financial reporting and more.

Here's how to access that menu:

Step 1:

Log-in with the email and password provided to you by us.

Step 2:

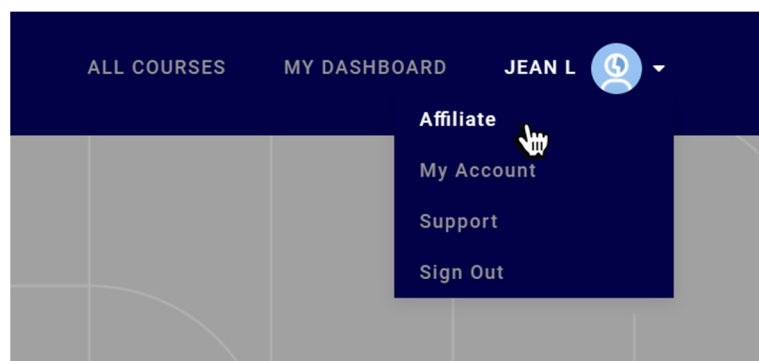
Access your affiliate dashboard menu by clicking the 'Affiliate' button in the top right corner.

About the Menu:

- General Affiliate Information: Details of your commission rate can be found here.
- Your Affiliate Links: Unique product codes are listed here for you to share with your audience. (or we can email them over should you get stuck!) Provided that a person's first ever visit to our site is via your affiliate link, this will be tracked so that if they go on to make a purchase you will be credited for that sale. This will happen even if the visitor doesn't sign up for a user account on our site at first. If they come back at a later point to sign up and make a purchase it will be credited to you...the first visit is the key!
- Financial Reports: Here you can see your commission totals, a breakdown of your individual commissions, your pay-outs and tracking on the number of visitors through your affiliate links.



4. Payment of Commissions

By joining the Hatch Programme Limited affiliate program your commission rate will be 25%.

Hatch Programme Limited will pay commissions on all qualifying affiliate sales.

You agree these qualifying commission amounts are your sole compensation for participating in the affiliate program.

Sales include all paid subscriptions initiating from new customers you refer, but does not include amounts credited for cancelled services or similar charges. (Which we would notify you of immediately should there ever be a problem).

Commissions will be paid at the end of each calendar month and you can easily track by signing into our portal.

We use a company called Transferwise.com which will send your commission to your bank account in your currency.

5. Returns and Reversals

We can't imagine a situation where this would ever arise with our online courses but it has to be said upfront for clarity!

Hatch Programme Limited takes pride in our low reversal rate; however, we reserve the right to reverse orders due to order cancellations, duplicate tracking, returns or disputed charges. Furthermore, if we request from you any clarification or additional information on any order or clicks that we feel may be in violation of our terms and conditions and you are either not forthcoming or intentionally vague or not responsive within a reasonable time period, we may reverse orders or suspend you from the program entirely.

6. Promotion Restrictions (General Niceties of working together!)

You may not claim to be Hatch Programme Limited at any time.

You may not create or design your website or any other website that you operate, explicitly or implied in a manner which resembles our website nor design your website in a manner which leads customers to believe you are Hatch Programme Limited.

7. Termination

Either you or we may end this Agreement AT ANY TIME, with or without cause, by giving the other party written notice. Written notice can be in the form of mail, email or fax. In addition, this Agreement will terminate immediately upon any breach of this Agreement by you.

8. Modification

We may modify any of the terms and conditions in this Agreement, at any time in our sole discretion. In such event you will be notified by email. Modifications may include, but are not limited to, changes in the payment procedures, and the Hatch Programme Limited Affiliate Program rules. If any modification is unacceptable to you, your sole recourse is to end this Agreement. Your continued participation in the Hatch Programme Limited Affiliate Program following the posting of the change notice or new Agreement on our site will indicate your acceptance of all changes therein.
